Applications will only be reviewed upon the submission of all required documents and application fee.

Requirements

1. Completed signed and notarized gas application form.
2. Two (2) current surveys (for Generator & Pool Heater installations)
 - Showing gas lines to equipment
3. All Plumber's must submit:
 - A copy of their Town of Hempstead, North Hempstead, or Town of Oyster Bay License.
 - General liability insurance with the Village of Hewlett Neck as the certificate holder and additionally insured.
 - Worker's compensation with the Village as the certificate holder.
 - Plumber's Competency Certificate.

Fee Schedule:

Application: \$150.00 (check made payable to the Village of Hewlett Neck) Due at the time of submission.)

Permit: \$50.00 Per Fixture

Gas Pressure Test Certificate: \$75.00

Any additional work will require an amendment to be filed with a new application
