RESOLVED, that the compensation for the services of the Village Attorney and other attorneys associated with their law firm designated by either Village Attorney as Deputy Village Attorneys, for retainer legal services (all legal services required by the Village other than legal services in connection with litigation matters, or Village acquisition or sale of real estate) to be performed by the Village Attorney or under his direction, shall be \$270 per hour, plus reimbursement of all reasonable and necessary disbursements incurred in connection with the performance of such retainer legal services, which sums will be billed to the Village monthly by the Village Attorney or any law firm with which he may be associated, and it is further

RESOLVED, that the Board of Trustees hereby retains Harris Beach PLLC As special counsel to the Village for non-retainer legal services as may be required, the services of such special counsel to be compensated at the rate of \$285 per hour, plus reimbursement of all reasonable and necessary disbursements incurred in connection with the performance of such non-retainer legal services, which sums shall be billed to the Village monthly, and be it further

RESOLVED, that the rate for the provisions of legal services by Harris Beach PLLC in connection with applications brought for zoning relief to the Zoning Board of Appeals or the Board of Trustees will be compensated at the rate of \$325 per hour, and be if further

RESOLVED, that the Mayor is authorized to sign the retainer agreement with Brian S. Stolar and Harris Beach PLLC

8. Public Hearing for Proposed Bill HN-2303- A local law to amend the Code of the Village of Hewlett Neck in relation to persons entitled to defense and indemnification in accordance with the Public Officers Law, in the Village of Hewlett Neck

The Mayor opened the public hearing. The Village Attorney explained the proposed local law. The Board confirmed that the hearing notice was published in the Nassau Herald and posted on the bulletin board outside of Village Hall and in the lobby of Village Hall and Village Website. Affidavits of posting and publication of the hearing notices are on file at the Village Clerk's office, and hearing no comments from the public, on motion duly made by the Mayor, seconded by Deputy Mayor Schnell and adopted unanimously, the Board closed the public hearing and adopted the following resolution:

RESOLVED, that the Board hereby finds and concludes that

- (a) Proposed .Law HN-2303 is an Unlisted Action under the State Environmental Quality Review Act and its regulations;
- (b) the Board is the lead agency with respect to environmental review of this proposed action;
- (c) the Board has considered the following factors in respect to its review of the environmental impacts of the proposed action:
- (i) whether the proposed action would result in any substantial adverse change in existing air quality, ground or surface water quality or quantity, traffic or noise levels, nor any substantial increase in solid waste production, nor create a substantial increase in the potential for erosion, flooding, leaching or drainage problems;

- (ii) whether the proposed action would result in the removal or destruction of large quantities of vegetation or fauna, substantial interference with the movement of any resident or migratory fish or wildlife species, impacts on a significant habitat area, substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such a species, or other significant adverse impacts to natural resources;
- (iii) whether the proposed action would impair the environmental characteristics of any Critical Environmental Area;
- (iv) whether the proposed action would conflict with the community's current plans or goals as official approved or adopted;
- (v) whether the proposed action would impair the character or quality of important historical, archeological, architectural or aesthetic resources or of existing community or neighborhood character;
- (vi) whether the proposed action would result in a major change in the use of either the quantity or type of energy;
- (vii) whether the proposed action would create a hazard to human health;
- (viii) whether the proposed action would create a substantial change in the use, or intensity of use, of land, including agricultural, open space or recreational resources, or in its capacity to support existing uses;
- (ix) whether the proposed action would encourage or attract large numbers of persons to any place for more than a few days, compared to the number who would come to such place without such action;
- (x) whether the proposed action would create changes in two or more elements of the environment, no one of which would have a significant impact on the environment, but when taken considered together would result in a substantial adverse impact on the environment;
- (xi) whether the proposed action would create substantial adverse impacts when considered cumulatively with any other actions, proposed or in process;
- (xii) whether the proposed action would result in substantial adverse impact with respect to any relevant environmental consideration, including noise, aesthetics, traffic, air quality, water quality or adequacy of water supply, drainage, soil conditions, or quality of life in the community in general and the immediate neighborhood in particular;
- (d) the proposed action, would not have a significant adverse environmental impact, as that impact is considered under SEQRA; and
- (e) no further environmental review is required with respect to the proposed action

RESOLVED, that the Board adopts Proposed Bill HN-2303 as Local Law HN-4-2023, and directs the Village Clerk to file Local Law HN-4-2023 with the New York Secretary of State and take all actions required by law.

#### 9. Resolution for the Creation of Reserve Account for Snow and Ice Removal

On motion by Mayor Epstein, seconded by Deputy Mayor Schnell and unanimously carried the following Resolution was adopted

RESOLVED, that pursuant to General Municipal Law (GML) 6-F, there is hereby established a capital reserve fund to be known as the "Snow and Ice Removal and Road Repair Fund" (the "Reserve Fund"). The purpose of this Reserve Fund is to accumulate

monies to finance the cost for the removal of snow and ice from public roadways and public places, which removal is of a type not likely to recur annually or at shorter intervals, for repairing and maintaining roadways to the extent damage to such roadways was caused by the removal of snow and ice including pothole repair and other road surface maintenance.

The Village Treasurer is hereby directed to deposit and secure the monies in this Reserve Fund in the manner provided by GML §10. The Board of Trustees may invest the monies in the Reserve Fund in the manner provided in GML §11, and consistent with the Investment Policy of the Village of Hewlett Neck. Any interest earned or capital gains realized on the monies deposited or invested shall accrue to and become part of the Reserve Fund. The Village Treasurer shall account for the Reserve Fund in a manner that maintains a separate identity of the Reserve Fund and shows the date and amount of each sum paid into the Fund, interest earned by the Fund, capital gains or losses resulting from the investments of the Fund, the amount and date of each withdrawal from the Fund and the total assets of the Fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Reserve Fund.

Except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of the Board of Trustees and such additional actions or proceedings as may be required by GML 6-F or any other law, including a permissive referendum if required by GML.

On motion by Mayor Epstein, seconded by Deputy Mayor Schnell and unanimously approved, the Treasurer was directed to move \$15,000 of unused snow removal money from fiscal ending 5/31/2023 to the Reserve Account for Snow and Ice Removal
