3. Notice of Meeting – Nassau Herald:

The Clerk reported that notice of the special meeting was emailed to the Nassau Herald and was posted on the bulletin board outside of Village Hall and in the lobby of Village Hall, and on the Village Website.

4. Building Inspector :

On motion duly made by Trustee Schnell, seconded by Deputy Mayor Hochberg, and adopted unanimously, the Board adopted the following resolution:

WHEREAS, On March 8, 2021, the Mayor appointed, and the Board approved the appointment of, Paul Lauria to serve as Village Building Inspector subject to the terms of a written agreement, for the balance of the Village official year, and

WHEREAS, prior to signing the agreement, on March 9, 2021, Mr. Lauria notified the Village that he did not intend to serve as the Building Inspector and did not execute the agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Board rescinds the appointment of Paul Lauria.

Mayor Epstein appoints Dennis Fromigia, to serve as Building Inspector for the Village for a term commencing on March 23 2021 and continuing through the end of the Village official year, subject to the terms of a proposed agreement, dated effective today.

On motion duly made by Trustee Schnell, seconded by Hochberg, and adopted unanimously, the Board adopted the following resolution:

WHEREAS, the Mayor has appointed Dennis Fromigia to serve as Building Inspector for the Village pursuant to the terms of a proposed agreement, dated effective today, for a term commencing on March 23, 2021 and concluding at the end of the current official year;

NOW, THEREFORE, the Board confirms and approves the appointment of Dennis Fromigia as Building Inspector for the term March 23, 2021 through the end of the official year, at the rates and subject to the conditions set forth in the proposed agreement dated today, approves the proposed agreement as to form, and upon execution of the agreement by Dennis Fromigia, authorizes the Mayor to execute the agreement on behalf of the Village.
